We formulate and continuously improve our environmental policies, clarifying our targets and responsibilities in biodiversity conservation. Adhering to the principle of green production, pollution and emission reduction, we implement a series of measures to establish a green supply chain and mitigate any negative ecological or environmental impact of our business activities.

对我们的运营工厂及相邻区域,利用了世界自然基金会的生物多样性风险评估工具——WWF Biodiversity Risk Filter 定期进行生物多样性风险评估,并进行依赖和缓解分析。我们对各基地的物理风险和声誉风险进行评估,根据世界自然基金会的建议,采取相应措施降低风险。并将识别出的风险纳入全公司的风险管理流程中,监控风险变化情况。

We use WWF's biodiversity risk assessment tool, the WWF Biodiversity Risk Filter, to regularly conduct biodiversity risk assessments, as well as dependency and mitigation analyses for our operating sites and adjacent areas. We assess physical risks and reputational risks of our production bases. Based on the assessment, we implement mitigation measures in alignment with WWF recommendations. The identified risks are also incorporated into our company's risk management system to monitor any changes in risk.

We apply the mitigation hierarchy of "Avoid, Reduce, Restore and Offset" prioritizing mitigation measures to minimize or offset the negative impacts of our operations on biodiversity and ecosystem, aiming to achieve no net loss. Our mitigation measures include, but are not limited to, participation in reforestation, wetland restoration, species conservation programs and more.

价值链合作与支持

Value Chain Cooperation and Support

我们将定期评估上游供应商及下游分销商的生物多样性风险。与供应商、当地社区以及项 目所在地的国家/地区合作,共同推动生物多样性保护工作。我们将提供必要的资源(包括 但不限于资金、物资、技术、人力等),帮助社区开展生态保护项目,促进生物多样性的 恢复和保护。同时督促供应商及合作伙伴签订供应商行为准则,要求停止森林砍伐现象, 支持生物多样性分析。

We will regularly assess biodiversity risks among our suppliers and distributors and cooperate with our business partners, local communities and host countries to collectively promote biodiversity conservation. We will allocate the necessary resources, including funds, materials, technology, personnel, to support community-led ecological conservation projects. Additionally, we require our suppliers to adhere to our "Supplier Code of Conduct, which prohibites deforestation activities and mandates biodiversity analysis.
